### 5. Learning outcomes of the curricular unit:

Acquire key concepts which are essential to understand the functioning of the United Nations (UN). Acquire understanding of the role of the UN in constituting and reconstituting world order. Develop the ability to analyze UN policies and practices, particularly regarding the use of force.

### 8. Teaching methodologies (including evaluation):

Theoretical introduction to each subject of the syllabus, through the use of the expositive method. Discussion and analysis of previously assigned reading material: historical documents, conventions, UN acts and caselaw. Oral and written presentation by Master Students on topics related to the syllabus (VII. The UN functions and VIII. Challenges: United Nations Reform). Evaluation: continuous assessment (25%), oral and written presentation (25%) and a written

exam (50%). Erasmus/mobility students' special evaluation: continuous assessment (50%), oral and written presentation (50%).

#### 9. Demonstration of the coherence between the teaching methodologies and the learning outcomes:

The theoretical introduction to each subject of the syllabus is designed to prepare Master Students to acquire key concepts which are essential to understand the functioning of the United Nations. Discussion and analysis of previously assigned reading material and assignments provide Master Students the ability to analyze UN policies and practices, understand and engage with contemporary issues and debates in international affairs and connect UN evolution to change and continuity in international relations.

#### 10: Evaluation:

Evaluation: continuous assessment (25%), oral and written presentation on topics related to the syllabus (VII. The UN functions) (25%) and a written exam (50%).

Erasmus/mobility students' special evaluation: continuous assessment (50%), oral and written presentation on topics related to the syllabus (VII. The UN functions and VIII. Challenges: United Nations Reform) (50%).
