Postgraduate Course "AI in Legal Practice and Its Regulation"

Applications for the Academic Year 2025/2026

1. APPLICATION DATES

- 1.1. Applications to the Postgraduate Course "AI in Legal Practice and Its Regulation" (hereinafter PG AI & Law) for the academic year 2025/2026 will be open in three phases:
- 1.1.1. Phase 1: from 15 of January to 28 of February of 2025;
- 1.1.2. **Phase 2**: from 15 of March to 30 of April of 2025;
- 1.1.3. **Phase 3**: from 1 of June to 15 of July of 2025.
- 1.2. Depending on the number of vacancies filled in the first one, the second and third round of applications may be opened.

2. APPLICATIONS SUBMISSION AND DOCUMENTS

- 2.1. The applications are exclusively submitted at FENIX Portal (Link: https://fenix.fd.ulisboa.pt).
- 2.2. Documents:
 - a) Curriculum vitae;
 - b) English proficiency certificate (if the candidate has one);
 - c) Citizen's card or identity card, or passport in the case of foreign students;
 - d) Passport-sized photo;
 - e) Certificate of completion of a Bachelor's degree, containing the final grade average and a list of subjects, or, if the candidate has not yet finished the degree, a certificate listing the subjects she/he has passed and the grades for each awarded; this certificate has to be properly certified with Hague's





Apostille or the stamp of the Portuguese embassy/consulate (only applied to foreign students and foreign universities);

- f) Certificate of completion of a Master's degree, containing the final grade and a list of subjects (if applicable);
- g) Certificate of completion of postgraduate courses (if applicable);
- h) Link to the website of the publisher, journal, or review where the candidate has published books or scientific papers (if applicable). This information may be included in the *curriculum vitae*.

The submission of academic documents containing false information is punishable by law.

3. TUITION FEES & OTHER EXPENSES

TUITION FEES

- Amount: €1.600
- Payment:
 - With registration (15% discount), or
 - €600 with registration + €500 by the start of the course and €500 by the 1st of January
- Students from the University of Lisbon Law School benefit from a 50% discount on the tuition fee.

OTHER FEES AND EXPENSES

- Application fee (non-refundable): € 100
- Insurance: € 2





4. VACANCIES

For the academic year 2025/2026, 40 vacancies will be open for the PG AI & Law.

5. SELECTION OF CANDIDATES AND ANNOUNCEMENT POF THE RESULTS

- 5.1. In accordance with article 5 of the PG AI & Law regulations, applications will be assessed and decided according to the candidates' curriculum vitae.
- 5.2. The selection of candidates will be announced until March 14 (phase 1), May 15 (phase 2) and until July 29 (phase 3) of 2025, unless a change is announced, on the course's website (www.ai-and-law-lisbon.com) in the section "Applications & Fees".

6. ENROLMENT

The enrolment period will be after the results announcement as follows:

Phase 1: 15 to 31 of March;

Phase 2: 16 to 31 of May;

Phase 3: 1 to 8 of August.
